## ***Circular to Chief Executive Officers of Commercial Banks, Credit Institutions and Microfinance Deposit-Taking Institutions***

### **Replacement of Tokens to access the Bank Supervision Application (BSA)**

We wish to remind you that the RSA SecurID tokens used by the Bank of Uganda Supervised Financial Institutions (SFIs) to access the Bank Supervision Application (BSA) System are due to expire on **January 31, 2017**.

Accordingly, with effect from **January 9, 2017**, the Bank of Uganda shall commence the exercise of replacing all the tokens held by all SFIs with the issuance of new tokens. The activation of new tokens and disabling of old tokens shall end on **January 13, 2017**. Accordingly, all SFIs are required to return all disabled tokens to BoU by **January 20, 2017**.

The purpose of this circular, therefore, is to request you to take note of these timelines and release at least one Chief Security Officer (CSO) from your institution to come to Plot 37, Bank of Uganda (RTGS Business Continuity Room located on the 3<sup>rd</sup> Floor) on **January 09, 2017** at **9.30am** to collect the new tokens.

We have attached a list of your nominated Chief Security Officers for ease of reference.
